Following recent events concerning goal posts being left up in Victory Avenue and volatile behaviour of residents to council staff who are carrying out their job, it was confirmed that the resident who owns the two goal posts had not been in contact to retrieve them. The council observed that there had been much debate regarding the goal posts on Mulberry Green and a discussion was had as to larger goal posts being sited there. This would be either instead of the existing or as an extra set. **AP** Clerk to look at the cost of goals and to present to council at a future meeting.

Appendix 1

District Councillor Report - Lisa Neal

Community Awards:

We are celebrating the stars of our Community. I will be attending the Awards Ceremony on the 30th June at Bawburgh Golf Club as two individuals have been nominated from my Ward.

Nutrient Neutrality:

You will be aware of the challenges that Norfolk local authorities and the development sector are facing in relation to nutrient neutrality. Significant progress has been made to tackle this issue and I believe that the work being done in Norfolk is now at the vanguard of the nationwide response to nutrient neutrality.

The most notable step forward in recent weeks is the establishment of a joint venture: Norfolk Environmental Credits Ltd, a not-for-profit company comprising of the affected local authorities and Anglian Water.

The aim of the Company will be to source nutrient mitigation and then sell phosphorus and nitrogen credits to developers and agents that otherwise would not be able to bring forward their housing schemes. Currently over 16,000 homes are on hold due to nutrient neutrality and whilst there are no credits available yet, discussions on several mitigation sources are at an advanced stage and we expect to be trading by late-summer. www.norfolkenvironmentalcredits.co.uk

Cabinet Meeting:

Parish/Town Forum:

Following the last Parish/Town Council Forum held on the 7th June, you should have received an email with all the presentations from the Forum. This covered funding that is available in respect of our "Pride in Place" scheme. I have attached them below in case you did not receive them.

East Anglia GREEN project:

I have attached below some information I have received regarding this project.

"We are continuing work to support the delivery of new sources of renewable energy to homes and businesses across East Anglia and the UK.

To make it clear that this work is part of The Great Grid Upgrade, we are changing the project name from East Anglia GREEN to 'Norwich to Tilbury'. All National Grid projects that are part of The Great Grid Upgrade will include specific locations in their names to make it easier for people to understand where we are proposing to build new grid infrastructure.

Norwich to Tilbury is one of a number of projects being developed as part of The Great Grid Upgrade – the largest overhaul of the grid in generations.

While we are still at an early stage of developing our proposals, we have made good progress since our consultation last year. We have reviewed all the feedback received and conducted surveys and assessments, alongside holding discussions with various stakeholders. We have made a number of changes and we will soon

publish our proposed preferred draft alignment, which will show potential positions for overhead lines and underground cables."

Appendix 3

County Councillor Report – Vic Thomson

I need to highlight to you that Poringland Primary will be over-subscribed for September's admissions with catchment children. As I write, there are 10 catchment children likely to be refused admission. 3 of these are being offered a place at a lower ranked preference school and the remaining children will be offered the next nearest school with a place available. Based on a quick assessment of these applicants the nearest schools to be offered will be Brooke Primary, Edith Cavell Academy or Lakenham Primary. Distances are such that transport will have to be provided.

The catchment cohort for Poringland is slightly higher this year causing the issue. (105 in catchment)

Trowse, Stoke Holy Cross, Alpington are also over-subscribed. With the additional offers, Brooke Primary will also be full.

Based on comments from the Place Planning Team, this a higher cohort than the last 4 years. The prediction was 98 and that has grown to 105. This is just the demographic in the area

Historical preference suggested we might see 64, although the management of places and the flow to Trowse means that preference is a little skewed and can vary from pattern, the options for alternative destinations are few as the smaller village primaries in the area are popular and oversubscribed

Norfolk County Council are looking for new hosts to join the hundreds of other Norfolk residents who have opened their homes and provided accommodation for a family or individuals from Ukraine.

The Homes for Ukraine scheme was launched in March 2022 to provide support to Ukraine following the Russian invasion in February 2022. The war in Ukraine has now entered its second year, and the need for support and compassion for those displaced by the conflict has not changed. We are still in need of people to host Ukrainian families; especially for guests who have been in Norfolk for a while now and are needing to move for employment, education or other reasons.

Cllr Margaret Dewsbury, cabinet member for communities and partnerships, said: "I'm really proud of our county and how quickly our residents responded to the call for help. Over 800 households have so far welcomed a guest, but we still need more hosts to come forward. In particular, we are looking for people who can help house families, so if you've got space, please get in touch with the team to find out more."

A range of ongoing support is on offer for hosts, including a monthly thank you payment of £500. Hosts also get support with all safeguarding and accommodation checks from Norfolk County Council, alongside our district, borough, city councils and voluntary sector partners. Information packs are available to help hosts with the settling-in period and provide information on the practical steps that guests will need help with, like setting up a bank account and finding work.

Throughout the time guests live with hosts, we also conduct welfare visits to support everyone to help make the hosting arrangement successful and rewarding. Once guests are ready to move on, either into their own

accommodation or to return to Ukraine, we have a range of practical support and services available to help this go smoothly.

Mary, who lives in Wretham, hosts a family from Ukraine. Alya who has 2 children came to the UK in April 2022. Mary supported Alya and her family to get their children into school and is hoping to host the family until the children have finished their schooling. The oldest child will then go onto college to study.

"The experience has been really rewarding," Mary said. "There is so much support on offer when you become a host, and I'd encourage anyone who is considering offering accommodation to get in touch with Norfolk County Council to see what's involved. The thank you payment is nice, but the whole process is worth far more to me than that. You get to help people in real need and see that you are making a difference to their lives - I'm so glad that I signed up!"

Maureen, who lives in Watton, responded to the call for hosts straight away, offering her spare room to Nadia, a 22-year-old from Ukraine, where she had an apartment and a good job. Her family are still in Ukraine, west of the capital. Using her background in vocational education, Maureen helped Nadia successfully apply for a job, and after being hosted for a number of months, Nadia now lives independently.

"The whole process has been so rewarding," Maureen said. "I'd encourage anyone to register their interest if they have space to become a host. You get a real feel-good factor that you're helping someone in need; it can be a mutually satisfying experience."
