#### 6. Draft for recommendation to Council for Comment

Initial feedback on the Policies had been sought from SNC in June, and was shared with the Committee. No major issues had been highlighted, but helpful guidance was given on ensuring each policy covers just one issue, not multiple, and it needs to be clear what the policy is trying to achieve. Each policy therefore needs to be directly linked with its corresponding objective.

It was also felt the Plan needed to include a definition of what was meant by 'starter homes' – ie: do we want to say 'home for social rent'? There was some querying of claiming Poringland as a 'Rural Exception Site', given the size and population of the village, and our policies must be double checked against the revised National Planning Policy Framework.

Following their review at the June Neighbourhood Plan Committee meeting, the policies had been edited to reflect feedback. They were subsequently reviewed again, and further amends were made directly to

the document in order to ensure readiness for a review at the Parish Council meeting on July 24<sup>th</sup>. Some policies were split into smaller single issue policies and wording was refined were appropriate.

The Chairman drew the Committee's attention to 'Building for Life' guide. This relates to a Government endorsed industry standard for well designed homes and neighbourhood. Local communities, local authorities and developers are encouraged to use it to guide discussions about creating good places to live.
